1. Aims

1.1. This policy aims to:

- Set out our approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers
- Explain how the academy will avoid discrimination in line with its legal duties under the Equality Act 2010
- Clarify the expectations for school uniform

2. Legal duties under the Equality Act 2010

2.1. The [Equality Act 2010](#) prohibits discrimination against an individual based on the protected characteristics, which include: age, sex, sexual orientation, disability, race, religion or belief, pregnancy and maternity, and gender reassignment.

2.2. To avoid discrimination, the academy will:

- Avoid listing uniform items based on sex, to give all pupils the opportunity to wear the uniform they feel most comfortable in
- Make sure that our uniform costs the same for all pupils
- Allow all pupils to have long hair, although we reserve the right to ask that long hair be tied back
- Allow all pupils to style their hair in a way that is appropriate for school, and makes them feel most comfortable
- Allow pupils to request changes to swimwear for religious reasons, or if they are experiencing discomfort
- Allow pupils to wear headscarves and/or other religious garments
- Allow pupils with sensory or physical needs to make reasonable adaptations to their uniform, depending on their specific needs
- Allow for reasonable adaptations to our policy on the grounds of equality by asking pupils or their parents/carers to get in touch with Mrs Steward (Principal), who can answer questions about the policy and respond to any requests. These will be considered on a case-by-case basis

3. Limiting the cost of school uniform

3.1. Our school has a duty to make sure that the uniform we require is affordable, in line with statutory [guidance](#) from the Department for Education (DfE) on the cost of school uniforms.

3.2. We understand that items with distinctive characteristics (such as branded items, or items that need to have a school logo attached or be in a unique fabric or style) cannot be purchased from a wide range of retailers, and that requiring many such items limits parents/carers' ability to shop around for the best price.

3.3. We will make sure our uniform:

- Is available at a reasonable cost
- Provides the best value for money for parents/carers

3.4. We will ensure this by:

3.4.1. Following the statutory limits for compulsory branded items of uniform and PE kit to a maximum of:

3.4.2. A branded school jumper for Reception to year 5

3.4.3. A branded school blazer for year 6

3.4.4. A school tie for years 4 to 6

3.4.5. Limiting compulsory branded items to low-cost and/or long-lasting items: such as ties

3.4.6. Considering cheaper alternatives to school-branded items, such as logos that can be ironed on, as long as this doesn't compromise quality and durability

3.4.7. Avoiding specific requirements for items such as coats, bags and shoes/trainers that pupils could also wear on non-school days. See more information in section 4.1

3.4.8. Avoiding different uniform requirements for different year/class/house groups

3.4.9. Avoiding different uniform requirements for extra-curricular activities including (but not limited to) sport, music and drama

3.4.10. Avoiding requiring different branded items for particular times of the year, such as a branded dress in summer and a branded skirt in winter

3.4.11. Considering alternative methods for signalling differences in groups for inter-school competitions, such as creating posters

3.4.12. Considering alternative approaches, including loaning compulsory branded items such as sports kit for competitions

3.4.13. Making sure that opportunities to acquire second-hand items in a timely manner are accessible to parents and carers of both current and prospective pupils, and publishing this information on our website

3.4.14. Avoiding frequent changes to uniform specifications, and minimising the financial impact on parents/carers of any changes

3.4.15. Consulting with parents/carers and pupils on any proposed significant changes to the uniform policy, and carefully considering any complaints about uniform in line with the school's complaints policy

3.4.16. Avoiding single-supplier contracts, to make sure generic items can be purchased from a range of retailers

3.4.17. Continuing to review this policy, to ensure the cost of our uniform is reasonable and provides the best value for money

4. Expectations for academy uniform

4.1. The academy uniform

4.1.1. It is important that all pupils wear the correct uniform for safety and to reflect our high standards of achievement and behaviour.

4.1.2. The uniform is as follows:

Nursery (Foundation One) to Year 3

Black tailored trousers or black skirt

White polo shirt

Academy jumper or cardigan

Black or white socks or tights

Black shoes

Year 4 and Year 5

Black tailored trousers or black skirt

White shirt (long or short sleeved)

Academy jumper or cardigan

Academy tie

Black or white socks or tights

Black shoes

Year 6

Black tailored trousers or black skirt

White shirt (long or short sleeved)

Academy blazer

Academy tie

Black or white socks or tights

Black shoes

Summer uniform

During the summer term pupils will be able to wear either a blue gingham summer dress or black tailored shorts.

Black skirt/pinafore/trousers

White short or long-sleeved shirt, polo shirt or aertex shirt

Bright blue sweatshirt with the OSPA logo or bright blue cardigan with the OSPA logo

A plain bright blue jumper or cardigan without the logo

Black or white socks/tights

Black shoes or all black training shoes (NO coloured markings, insignia, stripes etc)

Safe and sensible footwear, (i.e. no slip on mules, clogs or high heels).

PE. Clothing

Children need the following items:

Trainers/plimsolls for outdoor P.E. lessons

Black shorts and white t-shirt

Black track suit bottoms for outdoor P.E. in the cold weather

Black/navy zip up hoody or the OSPA blue PE hoody (optional)

Please also note the following which will be strictly enforced:

- Sensible, smart hairstyles (no Mohicans, hair extensions, hair dyes)
- No make-up, nail varnish or tattoos
- No jewellery, apart from watches and single stud earrings (these must be removed for PE or plasters provided from home to cover them)
- Mobile phones and all electronic devices are NOT allowed in school. If a pupil brings a mobile phone into school for exceptional reasons, it must be handed into the school office at the beginning of the day.

Children are invited to wear their own clothes on their Birthday. If their Birthday is on a weekend or in the holidays, then they can wear them on the Friday before or the Monday after.

4.2 Where to purchase uniform

4.2.1 School uniform can be purchased from Uniform Direct in Grimsby.

- We also have some brand new and pre-loved uniform available to purchase from the academy office, including ties
- We also take part in the local uniform swaps, supported by School Uniform Network Grimsby

5.Expectations for the academy community

5.1 Pupils

Pupils are expected to wear the correct uniform at all times (other than specified non-school uniform days) while:

5.1.1.1 On the school premises

5.1.1.2 Travelling to and from school

5.1.2 At off-site events or on trips that are organised by the school, or where they are representing the school (if required)

5.1.3 Pupils are also expected to contact Mrs Steward – Principal if they want to request an amendment to the uniform policy in relation to their protected characteristics.

5.2 Parents and carers

5.2.1 Parents and carers are expected to make sure their child has the correct uniform and PE kit, and that every item is:

5.2.1.1 Clean

5.2.1.2 Clearly labelled with the child's name

5.2.1.3 In good condition

5.2.2 Parents are also expected to contact Mrs Steward – Principal want to request an amendment to the uniform policy in relation to:

5.2.2.1 Their child's protected characteristics

5.2.2.2 The cost of the uniform

5.2.3 Parents are expected to lodge any complaints or objections relating to the school uniform in a timely and reasonable manner in accordance with the school's complaints policy.

5.2.4 Disputes about the cost of the school uniform will be:

5.2.4.1 Resolved locally

5.2.4.2 Dealt with in accordance with our school's complaints policy

5.2.5 The school will work closely with parents to arrive at a mutually acceptable outcome.

5.3 Staff

5.3.1 Staff will closely monitor pupils to make sure they are in correct uniform. They will give any pupils and families breaching the uniform policy the opportunity to comply, but will follow up with the principal if the situation doesn't improve.

5.3.2 Ongoing breaches of our uniform policy will be dealt with by offering support where possible.

5.3.3 In cases where it is suspected that financial hardship has resulted in a pupil not complying with this uniform policy, staff will take a mindful and considerate approach to resolving the situation and the pupil will not miss classroom teaching because of a sanction. This is in line with the statutory [guidance](#).

5.4 Governors

5.4.1 The governing body will review this policy to ensure it:

5.4.1.1 Is appropriate for the academy's context

5.4.1.2 Is implemented fairly across the school

5.4.1.3 Takes into account the views of parents and pupils

5.4.1.4 Offers a uniform that is appropriate, practical and safe for all pupils

5.4.2 The governing body will also ensure that the school's uniform supplier arrangements give the highest priority to cost and value for money

6 Monitoring arrangements

6.1 This policy will be reviewed annually by Mrs Steward – Principal. At every review, it will be approved by the governing body
